CONDITIONS OF SALE – Coins & Banknotes

The following Conditions of Sale, as amended by any published or posted notices or verbal announcements during the sale, constitute the entire terms and conditions on which property listed in the catalog shall be offered for sale or sold by Bonhams & Butterfields Auctioneers Corp. and any consignor of such property for whom we act as agent. If live online bidding is available for the subject auction, additional terms and conditions of sale relating to online bidding will apply; see <u>www.bonhams.com/</u><u>WebTerms</u> for the supplemental terms. As used herein, "Bonhams," "we" and "us" refer to Bonhams & Butterfields Auctioneers Corp.

1. Special Terms and Conditions Relating to Coins and Banknotes:

a. Bonhams has utilized adjectival, descriptive grading to describe the conditions of coins and banknotes in the catalog rather than the Sheldon numerical scale. Grading is subjective and open to interpretation. Prospective bidders are encouraged to make their own examination of the numismatic lots offered and not rely on any other party's opinion as to grade or other attributes, as opinions differ and grading standards change over time.

b. Many of the numismatic lots have been graded by third party grading service(s) including but not limited to PCGS, NGC, and/or ANACS. To the extent Bonhams provides such grading information in the cataloguing of a lot, it does so without any express or implied warranty or guarantee, and such information's inclusion does not mean that Bonhams or the consignor agrees or disagrees with the information that such third party grading service(s) have provided. Bonhams and its consignors shall not be bound by any prior or subsequent opinion or certification (or lack thereof) by any third party grading service, and bidders on numismatic lots hereby acknowledge and agree that any such opinion or certification (or lack thereof) shall not be used as the basis for any attempted rescission of sale. THE PURCHASER ASSUMES ALL RISKS RELATING TO GRADING, CONDITION, RARITY AND VALUATION OF NUMISMATIC LOTS.

c. Catalog illustrations of numismatic lots may not be to scale or reflect the depicted items' actual size.

d. All information regarding the description, condition, rarity, value or desirability of a given numismatic lot is ultimately subject to these Conditions of Sale and the Limited Right of Rescission set forth herein.

2. As used herein, the term "bid price" means the price at which a lot is successfully knocked down to the purchaser. The term "purchase price" means the aggregate of (a) the bid price, (b) a PREMIUM retained by us and payable by the purchaser EQUAL TO 17% OF THE BID PRICE, and (c) unless the purchaser is exempt by law from the payment thereof, any California, Arizona, Colorado, Connecticut, Florida, Georgia, Illinois, Massachusetts, Nevada, New York, Pennsylvania, Texas, Washington, D.C., Washington state, or other state or local sales tax (or compensating use tax) and other applicable taxes.

3. On the fall of the auctioneer's hammer, the highest bidder shall have purchased the offered lot in accordance and subject to compliance with all of the conditions set forth herein and (a) assumes full risk and responsibility therefor, (b) if requested will sign a confirmation of purchase, and (c) will pay the purchase price in full or such part as we may require for all lots purchased. No lot may be transferred. Any person placing a bid as agent on behalf of another (whether or not such person has disclosed that fact or the identity of the principal) may be jointly and severally liable with the principal under any contract resulting from the acceptance of a bid. Unless otherwise agreed, payment in good funds is due and payable within five (5) business days following the auction sale. Whenever the purchaser pays only a part of the total purchase price for one or more lots purchased, we may apply such payments, in our sole discretion, to the lot or lots we choose. Payment will not be deemed made in full until we have collected good funds for all amounts due.

Payment for purchases may be made in or by (a) cash, (b) cashier's check or money order, (c) personal check with approved credit drawn on a U.S. bank, (d) wire transfer or other immediate bank transfer, or (e) Visa, MasterCard, American Express or Discover credit, charge or debit card. A processing fee will be assessed on any returned checks. Please note that the amount of cash notes and cash equivalents that can be accepted from a given purchaser may be limited.

The purchaser grants us a security interest in the property, and we may retain as collateral security for the purchaser's obligations to us, any property and all monies held or received by us for the account of the purchaser, in our possession. We retain all rights of a secured party under the California Commercial Code. If the foregoing conditions or any other applicable conditions herein are not complied with, in addition to other remedies available to us and the consignor by law, including without limitation, the right to hold the purchaser liable for the purchase price, we at our option may either (a) cancel the sale, retaining as liquidated damages all payments made by the purchaser or (b) resell the property, either publicly or privately, and in such event the purchaser shall be liable for the payment of any deficiency plus all costs and expenses of both sales, our commission at our standard rates, all other charges due hereunder, attorneys' fees, expenses and incidental damages. In addition, where two or more amounts are owed in respect of different transactions by the purchaser to us, to Bonhams 1793 Limited and/or to any of our other affiliates, subsidiaries or parent companies worldwide within the Bonhams Group, we reserve the right to apply any monies paid in respect of a transaction to discharge any amount owed by the purchaser. If all fees, commissions, premiums, bid price and other sums due to us from the purchaser are not paid promptly as provided in these Conditions of Sale, we reserve the right to impose a finance charge equal to 1.5% per month on all amounts due to us beginning on the 31st day following the sale until payment is received, in addition to other remedies available to us by law.

4. We reserve the right to withdraw any property and to divide and combine lots at any time before such property's auction. Unless otherwise announced by the auctioneer at the time of sale, all bids are per lot as numbered in the catalog and no lots shall be divided or combined for sale.

5. We reserve the right to reject a bid from any bidder, to split any bidding increment, and to advance the bidding in any manner the auctioneer may decide. In the event of any dispute between bidders, or in the event the auctioneer doubts the validity of any bid, the auctioneer shall have sole and final discretion either to determine the successful bidder or to re-offer and resell the article in dispute. If any dispute arises after the sale, our sales records shall be conclusive in all respects.

6. If we are prevented by fire, theft or any other reason whatsoever from delivering any property to the purchaser or a sale otherwise cannot be completed, our liability shall be limited to the sum actually paid therefor by the purchaser and shall in no event include any compensatory, incidental or consequential damages.

7. If a lot is offered subject to a reserve, we may implement such reserve by bidding on behalf of the consignor, whether by opening bidding or continuing bidding in response to other bidders until reaching the reserve. If we have an interest in an offered lot and the proceeds therefrom other than our commissions, we may bid therefor to protect such interest. CONSIGNORS ARE NOT ALLOWED TO BID ON THEIR OWN ITEMS.

8. All statements contained in the catalog or in any bill of sale, condition report, invoice or elsewhere as to authorship, period, culture, source, origin, measurement, quality, rarity, provenance, importance, exhibition and literature of historical relevance, or physical condition ARE QUALIFIED STATEMENTS OF OPINION AND NOT REPRESENTATIONS OR WARRANTIES. No employee or agent of Bonhams is authorized to make on our behalf or on that of the consignor any representation or warranty, oral or written, with respect to any property.

9. All purchased property shall be removed from the premises at which the sale is conducted by the date(s) and time(s) set forth in the "Buyer's Guide" portion of the catalog. If not so removed, daily storage fees will be payable to us by the purchaser as set forth therein. We reserve the right to transfer property not so removed to an offsite warehouse at the purchaser's risk and expense, as set forth in more detail in the "Buyer's Guide." Accounts must be settled in full before property will be released. Packing and handling of purchased lots are the responsibility of the purchaser. Bonhams can provide packing and shipping services for certain items as noted in the "Buyer's Guide" section of the catalog.

10. The copyright in the text of the catalog and the photographs, digital images and illustrations of lots in the catalog belong to Bonhams or its licensors. You will not reproduce or permit anyone else to reproduce such text, photographs, digital images or illustrations without our prior written consent.

11. These Conditions of Sale shall bind the successors and assigns of all bidders and purchasers and inure to the benefit of our successors and assigns. No waiver, amendment or modification of the terms hereof (other than posted notices or oral announcements during the sale) shall bind us unless specifically stated in writing and signed by us. If any part of these Conditions of Sale is for any reason invalid or unenforceable, the rest shall remain valid and enforceable.

12. These Conditions of Sale and the purchaser's and our respective rights and obligations hereunder are governed by the laws of the State of California. By bidding at an auction, each purchaser and bidder agrees to be bound by these Conditions of Sale. Any dispute, controversy or claim arising out of or relating to this agreement, or the breach, termination or validity thereof, brought by or against Bonhams (but not including claims brought against the consignor by the purchaser of lots consigned hereunder) shall be resolved by the procedures set forth below.

Mediation and Arbitration Procedures

(a) Within 30 days of written notice that there is a dispute, the parties or their authorized and empowered representatives shall meet by telephone and/or in person to mediate their differences. If the parties agree, a mutually acceptable mediator shall be selected and the parties will equally share such mediator's fees. The mediator shall be a retired judge or an attorney familiar with commercial law and trained in or qualified by experience in handling mediations. Any communications made during the mediation process shall not be admissible in any subsequent arbitration,

mediation or judicial proceeding. All proceedings and any resolutions thereof shall be confidential, and the terms governing arbitration set forth in paragraph (c) below shall govern.

(b) If mediation does not resolve all disputes between the parties, or in any event no longer than 60 days after receipt of the written notice of dispute referred to above, the parties shall submit the dispute for binding arbitration before a single neutral arbitrator. Such arbitrator shall be a retired judge or an attorney familiar with commercial law and trained in or qualified by experience in handling arbitrations. Such arbitrator shall make all appropriate disclosures required by law. The arbitrator shall be drawn from a panel of a national arbitration service agreed to by the parties, and shall be selected as follows: (i) If the national arbitration service has specific rules or procedures, those rules or procedures shall be followed; (ii) If the national arbitration service does not have rules or procedures for the selection of an arbitrator, the arbitrator shall be an individual jointly agreed to by the parties. If the parties cannot agree on a national arbitration service, the arbitration shall be conducted by the American Arbitration Association, and the arbitrator shall be selected in accordance with the Rules of the American Arbitration Association. The arbitrator's award shall be in writing and shall set forth findings of fact and legal conclusions.

(c) Unless otherwise agreed to by the parties or provided by the published rules of the national arbitration service:

(i) the arbitration shall occur within 60 days following the selection of the arbitrator;

(ii) the arbitration shall be conducted in the designated location, as follows: (A) in any case in which the subject auction by Bonhams took place or was scheduled to take place in the State of New York or Connecticut or the Commonwealth of Massachusetts, the arbitration shall take place in New York City, New York; (B) in all other cases, the arbitration shall take place in the city of San Francisco, California; and

(iii) discovery and the procedure for the arbitration shall be as follows:

(A) All arbitration proceedings shall be confidential;

(B) The parties shall submit written briefs to the arbitrator no later than 15 days before the arbitration commences;

(C) Discovery, if any, shall be limited as follows: (I) Requests for no more than 10 categories of documents, to be provided to the requesting party within 14 days of written request therefor; (II) No more than two (2) depositions per party, provided however, the deposition(s) are to be completed within one (1) day; (III) Compliance with the above shall be enforced by the arbitrator in accordance with California law;

(D) Each party shall have no longer than eight (8) hours to present its position. The entire hearing before the arbitrator shall not take longer than three (3) consecutive days;

(E) The award shall be made in writing no more than 30 days following the end of the proceeding. Judgment upon the award rendered by the arbitrator may be entered by any court having jurisdiction thereof. To the fullest extent permitted by law, and except as required by applicable arbitration rules, each party shall bear its own attorneys' fees and costs in connection with the proceedings and shall share equally the fees and expenses of the arbitrator.

Limited Right of Rescission

If within one (1) year from the date of sale, the original purchaser (a) gives written notice to us alleging that the identification of Authorship (as defined below) of such lot as set forth in the **BOLD TYPE** heading of the catalog description of such lot (as amended by any saleroom notices or verbal announcements during the sale) is not substantially correct based on a fair reading of the catalog (including the terms of any glossary contained therein), and (b) within 10 days after such notice returns the lot to us in the same condition as at the time of sale, and (c) establishes the allegation in the notice to our satisfaction (including by providing one or more written opinions by recognized experts in the field, as we may reasonably require), then the sale of such lot will be rescinded and, unless we have already paid to the consignor monies owed him in connection with the sale, the original purchase price will be refunded.

If, prior to receiving such notice from the original purchaser alleging such defect, we have paid the consignor monies owed him in connection with the sale, we shall pay the original purchaser the amount of our commissions, any other sale proceeds to which we are entitled and applicable taxes received from the purchaser on the sale and make demand on the consignor to pay the balance of the original purchase price to the original purchaser. Should the consignor fail to pay such amount promptly, we may disclose the identity of the consignor and assign to the original purchaser our rights against the consignor with respect to the lot the sale of which is sought to be rescinded. Upon such disclosure and assignment, any liability of Bonhams as consignor's agent with respect to said lot shall automatically terminate.

The foregoing limited right of rescission is available to the original purchaser only and may not be assigned to or relied upon by any subsequent transferee of the property sold. The purchaser hereby accepts the benefit of the consignor's warranty of title and other representations and warranties made by the consignor for the purchaser's benefit. Nothing in this section shall be construed as an admission by us of any representation of fact, express or implied, obligation or responsibility with respect to any lot. THE PURCHASER'S SOLE AND EXCLUSIVE REMEDY AGAINST BONHAMS FOR ANY REASON WHATSOEVER IS THE LIMITED RIGHT OF RESCISSION DESCRIBED IN THIS SECTION.

"Authorship" means only the identity of the creator, the period, culture and source or origin of the lot, as the case may be, as set forth in the BOLD TYPE heading of the print catalog entry. The right of rescission does not extend to: (a) any grading information, opinion or certification of the subject lot, whether provided by Bonhams, the consignor or a third party grading service; (b) statements of condition, titles, descriptions, or other identification of offered lots, which information normally appears in lower case type below the **BOLD TYPE** heading identifying the Authorship; (c) Authorship of any lot where it was specifically mentioned that there exists a conflict of specialist or scholarly opinion regarding the Authorship of the lot at the time of sale; (d) Authorship of any lot which as of the date of sale was in accordance with the then generally-accepted opinion of scholars and specialists regarding the same; or (e) the identification of periods or dates of creation in catalog descriptions which may be proven inaccurate by means of scientific processes that are not generally accepted for use until after publication of the catalog in which the property is offered or that were unreasonably expensive or impractical to use at the time of such publication.

Catalogs

Before each auction we publish illustrated catalogs. Our catalogs provide descriptions and estimated values for each "lot." A lot may refer to a single item or to a group of items auctioned together. The catalogs also include the dates and the times for the previews and auctions. We offer our catalogs by subscription or by single copy. For information on subscribing to our catalogs, you may refer to the subscription form in this catalog, call our Client Services Department, or visit our website at www.bonhams.com/us.

Previews

Auction previews are your chance to inspect each lot prior to the auction. We encourage you to look closely and examine each object on which you may want to bid so that you will know as much as possible about it. Except as expressly set forth in the Conditions of Sale, items are sold "as is" and with all faults; illustrations in our catalogs, website and other materials are provided for identification only. At the previews, our staff is always available to answer your questions and guide you through the auction process. Condition reports may be available upon request.

Estimates

Bonhams catalogs include low and high value estimates for each lot, exclusive of the buyer's premium and tax. The estimates are provided as an approximate guide to current market value based primarily on previous auction results for comparable pieces, and should not be interpreted as a representation or prediction of actual selling prices. They are determined well in advance of a sale and are subject to revision. Please contact us should you have any questions about value estimates.

Reserves

Unless indicated by the p symbol next to the lot number, which denotes no reserve, all lots in the catalog are subject to a reserve. The reserve is the minimum auction price that the consignor is willing to accept for a lot. This amount is confidential and does not exceed the low estimate value.

Auction House's Interest in Property Offered at Auction

On occasion, Bonhams may offer a lot in which it has an ownership interest, in whole or in part. Such property, if any, is identified in the catalog with a \blacktriangle symbol next to the lot number.

Similarly, Bonhams may have an economic interest in a lot beyond its commission as a result of making an advance against anticipated proceeds to the consignor which is secured by the consigned property or where it has guaranteed the consignor a minimum auction price for consigned property. Such property, if any, is identified in the catalog with a \circ symbol next to the lot number.

Bidding at Auction

At Bonhams, you can bid in many ways: in person, via absentee bid, over the phone, or via Bonhams' live online bidding facility. Absentee bids can be submitted in person, online, via fax or via email.

Valid Bonhams client accounts are required to participate in bidding activity. You can obtain registration information online, at the reception desk or by calling our Client Services Department.

By bidding at auction, whether in person or by agent, by absentee bid, telephone, online or other means, the buyer or bidder agrees to be bound by the Conditions of Sale. Lots are auctioned in consecutive numerical order as they appear in the catalog. Bidding normally begins below the low estimate. The auctioneer will accept bids from interested parties present in the saleroom, from telephone bidders, and from absentee bidders who have left written bids in advance of the sale. The auctioneer may also execute bids on behalf of the consignor by placing responsive or consecutive bids for a lot up to the amount of the reserve, but never above it.

We assume no responsibility for failure to execute bids for any reason whatsoever.

In Person

If you are planning to bid at auction for the first time, you will need to register at the reception desk in order to receive a numbered bid card. To place a bid, hold up your card so that the auctioneer can clearly see it. Decide on the maximum auction price that you wish to pay, exclusive of buyer's premium and tax, and continue bidding until your bid prevails or you reach your limit. If you are the successful bidder on a lot, the auctioneer will acknowledge your paddle number and bid amount.

Absentee Bids

As a service to those wishing to place bids, we may at our discretion accept bids without charge in advance of auction online or in writing on bidding forms available from us. "Buy" bids will not be accepted; all bids must state the highest bid price the bidder is willing to pay. Our auction staff will try to bid just as you would, with the goal of obtaining the item at the lowest bid price possible. In the event identical bids are submitted, the earliest bid submitted will take precedence. Absentee bids shall be executed in competition with other absentee bids, any applicable reserve, and bids from other auction participants. A friend or agent may place bids on your behalf, provided that we have received your written authorization prior to the sale. Great Britain, Victoria, Una and the Lion Gold Five Pounds, 1839, Genuine, Filed Rims PCGS S-3851; Fr-386; KM-742. The so-called Una and the Lion is a British £5 gold coin minted in 1839 depicting Queen Victoria. Designed by William Wyon in 1839, to commemorate the beginning of Queen Victoria's reign (in 1837), it is now recognized as one of the most beautiful British coins ever struck. Interestingly enough, Una and the Lion is the lightest of the British £5 coins, weighing 38.7–39.3 grams.

The obverse depicts a young portrait of Victoria's head facing left, surrounded by the Latin phrase VICTORIA D: G: BRITANNIARUM REGINA F: D: -- (Victoria by the grace of God, Queen of the British Territories, defender of the faith). The reverse displays a depiction of Queen Victoria walking to the left of a lion. She is holding a scepter in her right hand, a globe in her left. The Latin phrase DIRIGE DEUS GRESSUS MEOS. -- (May the Lord direct my steps) is above, Roman numerals MDCCCXXXIX (1839) are below the base, W. WYON R.A. is at the rim. It is noted that the same Latin inscription appears on the 2012 Royal Mint £5 Crown, minted to commemorate the Diamond Jubilee of Queen Elizabeth II. The depiction of the young Queen as Lady Una (a character from Edmund Spenser's poem The Faerie Queene, from 1590) was seen at the time as a bold design decision as it was the first occasion when a British monarch had been depicted on a coin as a fictional character.

This is a beautiful specimen featuring deeply cameoed surfaces on each side. The fields are highly reflective and contrast nicely with the deeply frosted devices on the obverse and reverse. This is one of approximately 300 examples struck for inclusion in the British Coronation sets of 1839. It is remarkably free from scuffs and has a very minimum amount of the hairlines that many other examples of this rare coin fall victim to. Despite the disclaimer on the PCGS holder, even with close examination, we are unsure what the grader saw to indicate rim filing, as we cannot detect this. A personal examination is recommended, if for nothing else, to see the true beauty of this rare coin. **\$50,000 - 60,000**

A classic design by George Morgan, founded in a proposal by Representative John Adam Kasson for international coinage. The bright, reflective surfaces exhibit a pronounced cameo effect against the frosted devices. An interesting note: NONE of the typical striations are present on the obverse, with only a couple visible on the reverse star under very close examination. Could this be one of the 15 Originals which supposedly show no striations that were allegedly coined in 1879? It is thought that somewhere between 400 and 800 additional examples were struck in 1880 for distribution to selected politicians and others. One of the most popular of all American coins, enough to make Stellas one of the few Patterns included among regular issue coins in most reference books, The Guidebook to U.S. Coins, a notable example.

The Stellas are "international" not in their conformity to other world gold coins, but in the fact that they state their weight and the relative proportions of gold and silver on their face. Presumably, gold was more appreciated worldwide in 1879 than were U.S. dollars, thus it was easier to determine the value of 6 grams of pure gold than it was to convert \$4 based on some market or government-imposed rate. Regardless of intent, the Stella experiment failed and was abandoned. Ultimately, the dollar became an international currency all on its own, not due to experiments such as this, but because of the strength and stability of U.S. markets. The four dollar gold piece, or "Stella," (its official name per the enabling legislation) is one of the most prestigious and sought-after of all United States gold rarities. The derivation of the term Stella is one that, while often recapped in numismatic circles, is not completely understood by many. When gold coins were first struck in the Mint in 1795, they were based on a unit of value called the 'eagle.' The eagle, equal in value to ten dollars, had a factual design of an eagle on one side. If the eagle is worth ten dollars, it would follow that a half eagle would be worth half that amount, a quarter eagle two and a half dollars, and so on. The four dollar gold piece, when it was proposed in 1879-80 (the new denomination was the brainchild of John Kasson as an international metric coin), was meant to be a new base unit for gold coins. The planners decided on the name of Stella. Similar to the eagle and other gold coins based on the ten dollar gold standard, the statutory "Stella" has a star on the reverse, since 'Stella' means star in Latin. Charles Barber engraved the dies for the Flowing Hair Stella in 1879, although he modified a design earlier done by his father, William Barber, from the previous year (the father had died in August of 1879).

A sparkling Proof example of a collectible quality for this beautiful design with nicely reflective fields supporting the raised, lightly frosted devices. Gleaming luster blends effortlessly with pale golden highlights on the satiny devices. Noted are some light roller lines through the portrait and star as seen on most of these issues. Designed by Robert Scot, an unknown (but presumably small) number of 1795 eagles (several different die pairings) were struck on March 1, 1796 on Warrant No. 58, which had a total mintage of 1,169 pieces; an additional 116 pieces were again struck on March 30, 1796, according to Breen. The BD-3 is, by far, the rarest 1795 eagle die pairing. An estimate of fewer than 500 pieces were struck with only about 20 surviving examples known in all grades. In fact, the 1795 9 Leaves is probably the rarest issue as there is in the entire 138-year history of the denomination. John Dannreuther writes, "It is not known whether the 9 leaves on the branch indicate an experiment or a die cutting error, but the fact that the reverse was changed to 11 leaves for 1796 and 1797 indicates that it was an intentional experiment. Perhaps the arrangement of 13 leaves was considered too crowded and grouping of 9 leaves was thought too sparse, leading to the introduction of 11 leaves on the branch in 1796."

According to history, at the time this was minted, gold coins were important public relations items for the United States -- ambassadors to the world, as it were. Because of this, care was taken to avoid releasing gold coins with die breaks or other blunders into circulation. Today, it is believed that there are approximately 20 examples known, making it the rarest of the seven known Small Eagle varieties this year.

The 1795 9 Leaves ten dollar, as a variety, become all the more popular in recent decades upon the release of new research into early gold coins. This variety was apparently known as early as 1926 when Waldo Newcomer paid \$100 for a circulated example, several times the price for a more common 1795 13 Leaves variety. Since the 1960s, examples have been auctioned an average of once every two to three years.

This example exhibits a far better than average strike with the diagnostic die buckling in the field below the palm branch. The surfaces are mostly lustrous with the normal allotment of light handling marks. A couple of small marks are under ER of LIBERTY, a tiny black spot touches the lower right of the B, and another small mark is under ST of STATES on the reverse. Such minor ephemera are apparently common to most, if not all 9 Leaves coins, and their presence indicates nothing more than little pointers when differentiating one coin from another. The fields are semi-reflective, as often seen on 1795 eagles. An outstanding high grade example of the greatest rarity contained in the short-lived Small Eagle series of \$10 gold coins, 1795-97. The tiny mintage of only 158 pieces represents the largest single proof production of the Liberty double eagle type, but when studying the certified population figures, we find that many of these have been impaired or lost over the decades. Walter Breen stated in his *Proof Encyclopedia* (1977) that "Aside from Garrett's at \$6250 and Wolfson's, almost the only choice one auctioned in the last twenty years was that in KS 2/60; most others have been scrubbed or nicked up. Quoting the pathetic records on these would be a waste of time." In all Proof grades including Cameo examples, NGC has encapsulated 36 pieces, presumably a number of these reflect resubmissions. Only four pieces have been graded Proof 65 at NGC, all Cameo specimens. PCGS has certified only three examples as Proof 65 -- only a single Cameo, with none at a finer level at either service.

This is a remarkable Gem example with a full strike throughout including Liberty's hair, the obverse stars, and the center of the shield on the reverse. In 1903, the portrait of Liberty was lightly polished at the Mint, an attempt to eliminate cameo frosted heads as had become common to see, especially in the 1890s. While the profile certainly does not possess an Ultra Cameo contrast, the modest contrast between the deeply mirrored fields and the luminous portrait and eagle is unmistakable. Struck in deep yellow-gold with deeply mirrored fields, a single microscopic abrasion is on Liberty's vulnerable cheek. A mint-made lintmark on the reverse between UN of UNUM and the arrowhead group serves as a pedigree identifier for future identification. (PCGS 89119) **\$90,000 - 100,000**

Long considered "America's Most Beautiful Coin," Saint-Gaudens did a fantastic job of creating a new double eagle design to replace that of the long running Coronet Liberty head created by James Longacre. Since their introduction in 1907, High Relief specimens have been sought after by almost all collectors - even those with no numismatic exposure are always dazzled to see such a beautiful coin.

This is simply a phenomenal example of a Classic U.S. coin design. Multiple impressions of the dies on a medal press led to this piece being struck up in such high relief. Satiny luster and uniform yellow-gold color accent the already impressive visual appeal. Raised die swirls are seen in the fields, and velvet-like luster shifts on the top of Liberty's gown. The eagle is bold, lustrous and mark-free, and the wire rim is complete around each side. Specimens existing above this grade level are few and far between and with the prices of MS63 and MS64 examples continually increasing, the astute buyer would do well to acquire this magnificent Gem example. Augustus Saint-Gaudens' stunning portrayal of Liberty is struck up in full, high relief on this lovely specimen. Liberty's dress detail is immaculate and her legs are missing any mentionable nicks. The luster is uninterrupted as it flows freely across the fields and across the devices. Magnification reveals interwoven circles of light die polish; these raised circular die lines are seen on only the finest examples with surface preservation of the highest degree.

This beautiful coin issue was the result of work by Augustus Saint-Gaudens at the request of President Theodore Roosevelt. Roosevelt felt strongly about bringing beauty back to America's coinage that he felt was boring and nowhere near the distinction of many Ancient Greek coin designs. Through all of the ensuing problems Saint-Gaudens and Roosevelt endured from the political sewing circle of the time, the project was successful and finally approximately 11,250 High Relief examples were produced in 1907. This quantity of High Relief examples was sufficient enough to satisfy Roosevelt but also enough to cause mint officials to complain about the negative effect of their difficult-to-produce design. Lower relief dies with Arabic numerals were subsequently produced and the mass production of "Saints", as we know them as today, began in full force. Out of the estimated mintage figure of 11,250 pieces, there are two varieties struck from the same dies, Flat Rim (Edge) and Wire Rim (Edge). The Flat Rim examples are substantially more scarce, probably on an order of 2-3x as the more commonly seen Wire Rim. (PCGS 9136) **\$25,000 - 28,000**

One of the dreams in a collector's life is to own a fresh, lustrous example of this celebrated coin. For this isn't just any coin, but a lustrous, sharply struck up example with exceptional eye-appeal and no problems on either side. The boldness is outstanding. Accomplishing a complete strike was highly damaging to the dies on the 1907 high reliefs, and many show minor die cracks or other types of coining strain.

Records show that the dies for these coins were made by Mint Engraver Charles E. Barber from Saint-Gaudens' plaster mold. Barber, who did not like anyone impinging on his mint privileges, did his utmost to sabotage production of the "High Relief." Eventually, Barber got his way and a greatly reduced relief design was employed in late 1907, just months after the original design was adopted, but not before slightly more than 11,000 of these marvelous High Relief twenties were coined. The wire rim is seen on most examples is caused by metal flowing up from the three piece edge collar and dies producing a thin raised "fin" around part of the obverse and reverse margin. Examination with a glass will note only a few stray tick marks, nothing important or distracting. The strike is, of course, sharp and essentially complete. Bright yellow-golden color overall. K-6, R.4. After the appointment of Augustus Humbert as United States Assayer, the firm of Moffat & Co. included his name on the ingots and coins that it delivered. At this time, the company served as an officially sanctioned Assay Office for Gold Rush California. This is a visually impressive slug, as are they all, with rich green-gold coloration, and hints of red in some of the crevices of the design. Remaining detail is about average for the type, the obverse peripheral inscription discernible, and the eagle well detailed over all but the most central features. Scattered abrasions and heavy rim bruises are noted, but we stress that none of these distractions are overly out-of-context for a circulated gold coin of this size. A large counterstamp, "66?7 or 6687" is present at the center of the reverse. It was hastily impressed as the third digit or character is very low (a possible 8), and the first 6 is double struck. The origin and reason of this counterstamp is unknown to us at this time. A historically significant issue that enjoys unflagging collector demand in today's hobby. 1915-S \$50 Round MS64 PCGS. Commemorative coins are one of the most popular specialties in American numismatics. In this field there are several hundred different varieties with silver and gold coins from the Classic Era 1892 to 1954, plus a marvelous parade of modern issues since then. Among the classics, there are two pieces first and foremost in the limelight: the large, impressive, and rare \$50 "slugs" produced to the extent of just 1,500 pieces each, with a net distribution of far less (see descriptions below). The obverse of each issue features the helmeted head of Minerva, a classic touch, and an owl, representative of ancient Athens and knowledge, is on the reverse. While both are essentially the same motif, the octagonal differs inasmuch as dolphins are found within each angle. At the Exposition it seems that the octagonal format was the more interesting to buyers, evoking images of the famous Augustus Humbert \$50 pieces of the same shape issued during the Gold Rush in 1851 and 1852.

Regarding the event itself, the Panama-Pacific International Exposition, laid out on the shore of San Francisco Bay, was a veritable city of elegance. Buildings resembling temples were interspersed with sculpture and other art, truly a wonderland. Construction was mainly of a composition known as staff, resembling stone on the outside, but not durable. After the Exposition closed, the buildings were demolished, except for the Palace of Fine Arts, which remained and was used as a municipal store facility for fire engines and other equipment. Eventually, the heritage of the building was re-recognized, and today it stands in fine form and is an attraction for visitors. The fair opened with much publicity, and crowds rushed to see exhibits ranging from historical to scientific to the trappings of current life. A day could be spent at the Exposition without seeing even a fraction of what the exhibits offered. The concession for numismatic items was held by Farran Zerbe, a man of questionable ethics and reputation who earlier served as president of the American Numismatic Association. Zerbe was not held in high esteem by many if not most members of the ANA due to prior questionable dealings. The Association determined to hold its annual convention in San Francisco that year, with the Exposition as the prime drawing card, not to overlook Zerbe's impressive display there. On view for sale were all of the new commemoratives, including the silver half dollar, the gold dollar and guarter eagle, and both versions of the \$50. These were available in several forms including in envelopes and in leatherette cases. (After the Exposition closed, some sets were subsequently sold in copper frames -- as is this set.) The ANA convention was a flop, with fewer than two dozen people attending, the poorest turnout before or since. With regard to the commemoratives, the half dollar, gold dollar, and guarter eagle were sold in fair numbers to the public and others, but many thousands were melted. The story of the melting of the \$50 pieces is given below.

After the event closed, Zerbe mounted a campaign, including a mailing to banks, to sell more coins. Then he called it guits, and the unsold remaining coins were shipped to the Mint and melted. It did not take long before the coins achieved a premium value, and by the early 1920s the \$50 pieces were in strong demand. Ever since then, the value has gone up year by year, punctuated by the Depression, but still upward by the end of the 1930s. Today in 2013, all of the Panama-Pacific coins are strongly desired, with the \$50 pieces especially so. The beautiful quality of the coin offered here makes it especially appealing. Shimmering velvet mint bloom bathes both the obverse and reverse of this remarkably preserved example. Close examination of the surfaces yields the presence of only a very limited number of tiny defects (a rather amazing observation considering the open nature and fragility of this design). The rarity and importance of this issue is foremost among all of the commemoratives (whether they be gold, silver, platinum, or copper-nickel) in the U.S. coinage series. It is highly probable that no more than a handful of known survivors are within a condition range that clearly

surpasses the outstanding quality of the present specimen. Of the 1,500 pieces initially struck, 1,017 remained unsold and were subsequently melted, leaving a net mintage of just 483 coins. (PCGS 7451)

1915-S \$50 Octagonal MS63 NGC. During planning for the Panama-Pacific Exposition's coin striking ceremony, the Philadelphia Mint shipped a 14-ton hydraulic press to the fairgrounds for the specific purpose of minting these large \$50 gold pieces. (Research has not been able to ascertain how they managed it: probably the press went disassembled by ship). On June 15, the first octagonal pieces were struck at a ceremony which attracted VIPs from over the world. The ceremony had been arranged by Farran Zerbe, then possibly the best known numismatist of his day. Zerbe had the political influence to have himself put in charge of the Exposition's Coin and Medal Department, which was named in the authorizing act as responsible for distributing the commemorative coins. Zerbe set up his own collection (over 20,000 specimens) in a trellised display area of the Palace of Liberal Arts on the Exposition grounds labeling it Zerbe's Unique Money of the World. It became one of the more popular displays, and the Panama-Pacific Commemorative coins, each with its own story appended, were probably seen by several million visitors between the Exposition's opening February 20 and its close on December 4, 1915.

Each side of this coin presents a bright golden appearance. Elusive and quite costly as so few were distributed at the time of issue due to initial cost, this example is free of any mentionable abrasions. The strike, while almost always sharp, shows clear detail in the stylized leafy branch on the helmet as well as Minerva's cascading hair, and both sides reveal splendid surface preservation. On the \$50 octagonal only, there are eight dolphins on each side inserted between the outer edge and inner circular border. (PCGS 7452)

1915-S \$2.5 MS65 PCGS. A frosty Gem example. Mostly brilliant surfaces with a sharp strike for the type. From a scant mintage of just 6,749 pieces, only a small proportion of the survivors could match the quality offered here. An interesting fact: the single coin price for the quarter eagle at the time of issue was \$4.00. Charles E. Barber and George T. Morgan created the designs. (PCGS 7450)

1915-S G\$1 MS63 PCGS. A well struck example of this issue features the left-facing bust of a Panama Canal workman; the simple reverse has two dolphins above and below the denomination. A brightly lustrous, light golden example of which just 15,000 pieces were minted. (PCGS 7449)

1915-S 50C MS63 PCGS. A Select quality specimen commemorating the Panama Canal and the Exposition at San Francisco. Rich, satiny luster and virtually mark-free fields contribute to this coin's overall appeal and an abundant amount of rich, natural toning is icing on the cake. Though the second commemorative half dollar issued, it was the first to have the motto IN GOD WE TRUST included in the design. Single examples of the half dollar were offered as souvenirs to visitors at the 1915 Panama-Pacific Exposition. The single coin price at the time of issue was \$1.00. (PCGS 9357)

Copper Frame of Issue. When Farran Zerbe promoted the Panama-Pacific commemorative coinage, he developed several purchase options ranging from a single half dollar in an imprinted paper envelope to a massive 10-piece double coin set in an ornate copper frame. The tenpiece set was designed to show both the obverse and reverse of each of the five different coins, including four of the large \$50 pieces. As is the case with this lot, this is a five piece set that was housed in a copper frame. Three, four, and five piece sets were also available in smaller velvet-lined leather cases, or individual \$50 pieces in leather and velvet cases.

This is an original hammered copper frame made by Shreve & Co. of San Francisco, designed to hold an original five-coin set of Panama-Pacific commemorative coins. The frame is near-mint with a tiny scratch on the left side, the purple velvet interior is pristine. The original glass was broken at one time and has since been replaced with high-quality UV Plexiglas. This is one of the finer quality copper frames we have handled. The frame was designed with a back that allowed for a table top presentation with an easel or for a wall mounting.
