Please read the Conditions of Sale regarding the removal of sold lots.

Bonhams' storage and logistics partner is Box Brothers, a well-known organization that specializes in crating, packaging and shipping.

Our storage and logistics partnership provides several beneficial services. The first being 5 days of free storage.

- During this auction, clients will be expected to pick up all property from Bonhams by 5pm on Monday December 16, 2013.
- All items listed at the beginning of our printed catalog, along with all other items
  purchased, if not removed immediately after the sale, will be transferred to Box
  Brothers warehouse. With an appointment made 24 hours in advance, clients can pick

- Box Brothers will charge an uplift fee to transport your items to their warehouse. Small
  items that can be handled easily by one person will be charged \$50. Larger items
  that can still be handled by one person will be charged \$85. Large items that require
  two people to handle will be charged \$100. Charges will be payable directly to Box
  Brothers. Should you choose to have Box Brothers ship or deliver your property, this
  uplift fee will be waived.
- Clients will have 5 days of free storage to retrieve their property or make arrangements with Box Brothers to pack and ship their property. Storage fees will begin to accrue on the 6th day of storage.
- Retrieval from the offsite warehouse is by appointment only. Clients must call 24 hours
  in advance. Clients can utilize the delivery services offered by Box Brothers or clients may

- Box Brothers is available to ship internationally. They offer importing and exporting services. Clients can select either airfreight or ocean cargo delivery options, which range from door-to-port, door-to-airport with door-to-door service also available. - All purchases not designated for offsite storage will remain onsite at Bonhams for

#### **CONDITIONS OF SALE**

The following Conditions of Sale, as amended by any published or posted notices or verbal announcements during the sale, constitute the entire terms and conditions on which property listed in the catalog shall be offered for sale or sold by Bonhams & Butterfields Auctioneers Corp. and any consignor of such property for whom we act as agent. If live online bidding is available for the subject auction, additional terms and conditions of sale relating to online bidding will apply; see <a href="https://www.bonhams.com/WebTerms">www.bonhams.com/WebTerms</a> for the supplemental terms. As used herein, "Bonhams," "we" and "us" refer to Bonhams & Butterfields Auctioneers Corp.

- 1. As used herein, the term "bid price" means the price at which a lot is successfully knocked down to the purchaser. The term "purchase price" means the aggregate of (a) the bid price, (b) a PREMIUM retained by us and payable by the purchaser EQUAL TO 25% OF THE FIRST \$100,000 OF THE BID PRICE, 20% OF THE AMOUNT OF THE BID PRICE ABOVE \$100,000 UP TO AND INCLUDING \$2,000,000, AND 12% OF THE AMOUNT OF THE BID PRICE OVER \$2,000,000, and (c) unless the purchaser is exempt by law from the payment thereof, any California, Arizona, Colorado, Connecticut, Florida, Georgia, Illinois, Massachusetts, Nevada, New York, Pennsylvania, Texas, Washington, D.C., Washington state, or other state or local sales tax (or compensating use tax) and other applicable taxes.
- 2. On the fall of the auctioneer's hammer, the highest bidder shall have purchased the offered lot in accordance and subject to compliance with all of the conditions set forth herein and (a) assumes full risk and responsibility therefor, (b) if requested will sign a confirmation of purchase, and (c) will pay the purchase price in full or such part as we may require for all lots purchased. No lot may be transferred. Any person placing a bid as agent on behalf of another (whether or not such person has disclosed that fact or the identity of the principal) may be jointly and severally liable with the principal under any contract resulting from the acceptance of a bid.

Unless otherwise agreed, payment in good funds is due and payable within five (5) business days following the auction sale. Whenever the purchaser pays only a part of the total purchase price for one or more lots purchased, we may apply such payments, in our sole discretion, to the lot or lots we choose. Payment will not be deemed made in full until we have collected good funds for all amounts due.

Payment for purchases may be made in or by (a) cash, (b) cashier's check or money order, (c) personal check with approved credit drawn on a U.S. bank, (d) wire transfer or other immediate bank transfer, or (e) Visa, MasterCard, American Express or Discover credit, charge or debit card. A processing fee will be assessed on any returned checks. Please note that the amount of cash notes and cash equivalents that can be accepted from a given purchaser may be limited.

The purchaser grants us a security interest in the property, and we may retain as collateral security for the purchaser's obligations to us, any property and all monies held or received by us for the account of the purchaser, in our possession. We retain all rights of a secured party under the California Commercial Code. If the foregoing conditions or any other applicable conditions herein are not complied with, in addition to other remedies available to us and the consignor by law, including without limitation, the right to hold the purchaser liable for the purchase price, we at our option may either (a) cancel the sale, retaining as liquidated damages all payments made by the purchaser or (b) resell the property, either publicly or privately, and in such event the purchaser shall be liable for the payment of any deficiency plus all costs and expenses of both

- sales, our commission at our standard rates, all other charges due hereunder, attorneys' fees, expenses and incidental damages. In addition, where two or more amounts are owed in respect of different transactions by the purchaser to us, to Bonhams 1793 Limited and/ or to any of our other affiliates, subsidiaries or parent companies worldwide within the Bonhams Group, we reserve the right to apply any monies paid in respect of a transaction to discharge any amount owed by the purchaser. If all fees, commissions, premiums, bid price and other sums due to us from the purchaser are not paid promptly as provided in these Conditions of Sale, we reserve the right to impose a finance charge equal to 1.5% per month on all amounts due to us beginning on the 31st day following the sale until payment is received, in addition to other remedies available to us by law.
- 3. We reserve the right to withdraw any property and to divide and combine lots at any time before such property's auction. Unless otherwise announced by the auctioneer at the time of sale, all bids are per lot as numbered in the catalog and no lots shall be divided or combined for sale.
- 4. We reserve the right to reject a bid from any bidder, to split any bidding increment, and to advance the bidding in any manner the auctioneer may decide. In the event of any dispute between bidders, or in the event the auctioneer doubts the validity of any bid, the auctioneer shall have sole and final discretion either to determine the successful bidder or to re-offer and resell the article in dispute. If any dispute arises after the sale, our sales records shall be conclusive in all respects.
- 5. If we are prevented by fire, theft or any other reason whatsoever from delivering any property to the purchaser or a sale otherwise cannot be completed, our liability shall be limited to the sum actually paid therefor by the purchaser and shall in no event include any compensatory, incidental or consequential damages.
- 6. If a lot is offered subject to a reserve, we may implement such reserve by bidding on behalf of the consignor, whether by opening bidding or continuing bidding in response to other bidders until reaching the reserve. If we have an interest in an offered lot and the proceeds therefrom other than our commissions, we may bid therefor to protect such interest. CONSIGNORS ARE NOT ALLOWED TO BID ON THEIR OWN ITEMS.
- 7. All statements contained in the catalog or in any bill of sale, condition report, invoice or elsewhere as to authorship, period, culture, source, origin, measurement, quality, rarity, provenance, importance, exhibition and literature of historical relevance, or physical condition ARE QUALIFIED STATEMENTS OF OPINION AND NOT REPRESENTATIONS OR WARRANTIES. No employee or agent of Bonhams is authorized to make on our behalf or on that of the consignor any representation or warranty, oral or written, with respect to any property.
- 8. All purchased property shall be removed from the premises at which the sale is conducted by the date(s) and time(s) set forth in the "Buyer's Guide" portion of this catalog. Property designated with a "W" and associated purchased lots, if not removed promptly following sale, will be transferred to an offsite warehouse at the purchaser's risk and expense, as set forth in more detail in the "Buyer's Guide." Purchased property that is permitted to remain onsite at Bonhams' facility should be removed at the purchaser's expense not later than 5:00 p.m. Pacific Time five (5) business days following the date of the sale. If not so removed, a storage fee of \$5.00 per lot per day will be payable to us by the purchaser beginning at the close of the

- 21st day following the sale, and we may thereafter transfer such property to an offsite warehouse at the purchaser's risk and expense. Accounts must be settled in full before property will be released. Packing and handling of purchased lots are the responsibility of the purchaser. Bonhams can provide packing and shipping services for certain items as noted in the "Buyer's Guide" section of the catalog.
- 9. The copyright in the text of the catalog and the photographs, digital images and illustrations of lots in the catalog belong to Bonhams or its licensors. You will not reproduce or permit anyone else to reproduce such text, photographs, digital images or illustrations without our prior written consent.
- 10. These Conditions of Sale shall bind the successors and assigns of all bidders and purchasers and inure to the benefit of our successors and assigns. No waiver, amendment or modification of the terms hereof (other than posted notices or oral announcements during the sale) shall bind us unless specifically stated in writing and signed by us. If any part of these Conditions of Sale is for any reason invalid or unenforceable, the rest shall remain valid and enforceable.
- 11. These Conditions of Sale and the purchaser's and our respective rights and obligations hereunder are governed by the laws of the State of California. By bidding at an auction, each purchaser and bidder agrees to be bound by these Conditions of Sale. Any dispute, controversy or claim arising out of or relating to this agreement, or the breach, termination or validity thereof, brought by or against Bonhams (but not including claims brought against the consignor by the purchaser of lots consigned hereunder) shall be resolved by the procedures set forth below.

#### Mediation and Arbitration Procedures

- (a) Within 30 days of written notice that there is a dispute, the parties or their authorized and empowered representatives shall meet by telephone and/or in person to mediate their differences. If the parties agree, a mutually acceptable mediator shall be selected and the parties will equally share such mediator's fees. The mediator shall be a retired judge or an attorney familiar with commercial law and trained in or qualified by experience in handling mediations. Any communications made during the mediation process shall not be admissible in any subsequent arbitration, mediation or judicial proceeding. All proceedings and any resolutions thereof shall be confidential, and the terms governing arbitration set forth in paragraph (c) below shall govern.
- (b) If mediation does not resolve all disputes between the parties, or in any event no longer than 60 days after receipt of the written notice of dispute referred to above, the parties shall submit the dispute for binding arbitration before a single neutral arbitrator. Such arbitrator shall be a retired judge or an attorney familiar with commercial law and trained in or qualified by experience in handling arbitrations. Such arbitrator shall make all appropriate disclosures required by law. The arbitrator shall be drawn from a panel of a national arbitration service agreed to by the parties, and shall be selected as follows: (i) If the national arbitration service has specific rules or procedures, those rules or procedures shall be followed; (ii) If the national arbitration service does not have rules or procedures for the selection of an arbitrator, the arbitrator shall be an individual jointly agreed to by the parties. If the parties cannot agree on a national arbitration service, the arbitration shall be conducted by the American Arbitration Association, and the arbitrator shall be selected in accordance with the Rules of the American Arbitration Association. The arbitrator's award shall be in writing and shall set forth findings of fact and legal conclusions.

#### **CONDITIONS OF SALE - CONTINUED**

- (c) Unless otherwise agreed to by the parties or provided by the published rules of the national arbitration service:
- (i) the arbitration shall occur within 60 days following the selection of the arbitrator;
- (ii) the arbitration shall be conducted in the designated location, as follows: (A) in any case in which the subject auction by Bonhams took place or was scheduled to take place in the State of New York or Connecticut or the Commonwealth of Massachusetts, the arbitration shall take place in New York City, New York; (B) in all other cases, the arbitration shall take place in the city of San Francisco, California; and
- (iii) discovery and the procedure for the arbitration shall be as follows:
- (A) All arbitration proceedings shall be confidential;
- (B) The parties shall submit written briefs to the arbitrator no later than 15 days before the arbitration commences;
- (C) Discovery, if any, shall be limited as follows: (I) Requests for no more than 10 categories of documents, to be provided to the requesting party within 14 days of written request therefor; (II) No more than two (2) depositions per party, provided however, the deposition(s) are to be completed within one (1) day; (III) Compliance with the above shall be enforced by the arbitrator in accordance with California law;
- (D) Each party shall have no longer than eight (8) hours to present its position. The entire hearing before the arbitrator shall not take longer than three (3) consecutive days;
- (E) The award shall be made in writing no more than 30 days following the end of the proceeding. Judgment upon the award rendered by the arbitrator may be entered by any court having jurisdiction thereof.

To the fullest extent permitted by law, and except as required by applicable arbitration rules, each party shall bear its own attorneys' fees and costs in connection with the proceedings and shall share equally the fees and expenses of the arbitrator.

#### **Limited Right of Rescission**

If within one (1) year from the date of sale, the original purchaser (a) gives written notice to us alleging that the identification of Authorship (as defined below) of such lot as set forth in the BOLD TYPE heading of the catalog description of such lot (as amended by any saleroom notices or verbal announcements during the sale) is not substantially correct based on a fair reading of the catalog (including the terms of any glossary contained therein), and (b) within 10 days after such notice returns the lot to us in the same condition as at the time of sale, and (c) establishes the allegation in the notice to our satisfaction (including by providing one or more written opinions by recognized experts in the field, as we may reasonably require), then the sale of such lot will be rescinded and, unless we have already paid to the consignor monies owed him in connection with the sale, the original purchase price will be refunded.

If, prior to receiving such notice from the original purchaser alleging such defect, we have paid the consignor monies owed him in connection with the sale, we shall pay the original purchaser the amount of our commissions, any other sale proceeds to which we are entitled and applicable taxes received from the purchaser on the sale and make demand on the consignor to pay the balance of the original purchase price to the original purchaser. Should the consignor fail to pay such amount promptly, we may disclose the identity of the consignor and assign to the original purchaser our rights against the consignor with respect to the lot the sale of which is sought to be rescinded. Upon such disclosure and assignment, any liability of Bonhams as consignor's agent with respect to said lot shall automatically terminate.

The foregoing limited right of rescission is available to the original purchaser only and may not be assigned to or relied upon by any subsequent transferee of the property sold. The purchaser hereby accepts the benefit of the consignor's warranty of title and other representations and warranties made by the consignor for the purchaser's benefit. A lot may refer to a single item or to a group of items auctioned together. We offer our catalogs by subscription or by single copy. #### Previews

Auction previews are your chance to inspect each lot prior to the auction. ## **BIDDING AT AUCTION**

At Bonhams, you can bid in many ways: in person, via absentee bid, over the phone, or via Bonhams' online bidding facility. Absentee bids can be submitted in person, online, via fax or via email.

A valid Bonhams client account is required to participate in bidding activity. You can obtain registration information online, at the reception desk or by calling our Client Services Department.

Lots are auctioned in consecutive numerical order as they appear in the catalog. Bidding normally begins below the low estimate. The auctioneer will accept bids from interested parties present in the saleroom, from telephone bidders, and from absentee bidders who have left written bids in advance of the sale. The auctioneer may also execute bids on behalf of the consignor up to the amount of the reserve, but never above it.

We assume no responsibility for failure to execute bids for any reason whatsoever.

#### In Persor

If you are planning to bid at auction, you will need to register at the reception desk in order to receive a numbered bid card. To place a bid, hold up your card so that the auctioneer can clearly see it. Decide on the maximum amount that you wish to pay, exclusive of buyer's premium and tax, and continue bidding until your bid prevails or you reach your limit. If you are the successful bidder on a lot, the auctioneer will acknowledge your paddle number and bid amount.

#### Absentee Bids

As a service to those wishing to place bids, we may at our discretion accept bids without charge in advance of sale by telephone, by facsimile or in writing on bidding forms available from us. # The Largest Recorded Fine Black Opal Nodule—"Halley's Comet" —Listed in the Guinness Book of World Records

Leaning Tree Claim, 3-Mile Black Opal Field, Lunatic Hill, Lightning Ridge, New South Wales, Australia

Recorded in the Guinness Book of World Records as the world's largest uncut black opal nodule (or "nobby" as this formation is known in the opal trade), "Halley's Comet" is most certainly a unique specimen of great fame. Deriving its name from Halley's Comet which appeared in Australian skies at the time of the find in on November 3, 1986, the monster stone of nearly 2000 carats, as large as the size of a man's clenched fist, was found by a group of five opal miners known as "The Lunatic Hill Syndicate". The partnership was named for the location of their open-cut mine that was the size of a football field on the Leaning Tree Claim in the 3-Mile Black Opal Field in Lightning Ridge.

The area had been mined since the early 1900s but had never produced a stone as big as the present specimen. This claim became so named because gougers working in the shallow flat below this hill upon which the claim is situated, jokingly considered anybody to be a lunatic who would go up a hill only to sink all the way down to the horizontally trending opal dirt levels. In those days, most of the black opals were mined at what was known as the "3 mile shallows", at an average depth of 2 to 5 meters, located just 200 meters downhill from the present opencut. One day a lone miner decided to try his luck and dig a mine-shaft on top of the hill in the deep ground. The common belief in those times was that it was a waste of time and that no opal was ever found at such a depth, and what on earth was the lunatic doing, digging a shaft there? From that day forward that ridge was called "Lunatick Hill" by the old timers. In the end, it proved to be the richest-ever area in the region.

Lunatics or not, some few men dared do just that and with amazing results. The present specimen was found at a depth of twenty meters. The Leaning Tree Claim open-cut site remains one of Lightning Ridge's biggest tourist attractions to this day and is in the process of being Heritage listed.

More than 100,000 cubic meters of dirt were processed in an agitator (a converted concrete mixer the likes of which is typically used at Lightning Ridge to wash the opal "pay dirt") from which emerged stones ranging from 10 carats to 80 carats in addition to the 2000 carats monster "nobby".

Known internationally as one of the finest quality black opals, "Halley's Comet" exhibits a thick, black gem-grade opal color bar measuring approximately 1 inch (25mm) at its widest point that circumscribes the entire specimen at its equatorial center.

The floral, harlequin pattern of gem-quality green, blue-violet and yellow, play-of-color is a five out of five.

The largest gem "nobby" to be found at the famed locality of Lightning Ridge, "Halley's Comet" is the third largest gem grade black opal ever recorded, the largest one extant, and the largest specimen ever found in this region.

This is the largest black opal to be offered at public auction to our knowledge and, as such a trophy, it deserves a central place in any serious opal collection and should be preserved as an example of Australian national heritage.





Largest Surviving Mintabie Opal Specimen--'The Mintabie Queen' Mintabie, South Australia

Mintabie, in South Australia, is situated some 240 kilometers north west of Coober Pedy, which has for many years been the major world supplier of gem grade precious opal but even Coober Pedy was surpassed by Mintabie for 5 or 6 years in the late 1980s.

While opal was first found there in 1919, the remoteness of the area, lack of water and hard rock precluded the area from being mined on a regular basis until 1976 – 77. After a peak in production in the late 1980s – mining has now markedly declined. There is very little mining and very little opal is being produced.

Opal is found in the Palaeozoic rocks, in the Mintabie silicified sandstone. It is this silicification which has made the Mintabie beds hard to work, to the extent that explosives and large bulldozers are required to break up the sandstone. Large rippers behind the bulldozers rip up the sandstone beds and 'spatters' walking behind try and detect if any opal has surfaced.

The precious opal is found in-filling horizontal structures and vertical joints throughout the Mintabie sandstone beds, from the surface down to a depth of 30 meters.

Mintabie opal often shows distinct dark and light bands, often with much of the color in the paler or crystal opal bands. This opal is cut so that the brilliantly colored crystal overlies and is displayed against the black potch background. This is known as the Mintabie 'black opal' or 'semi black opal'. While some opal has the vivid play of colors in a black body, as is found in Lightning Ridge, there is also the lower grade milky opal, jelly opal and abundant blue—black opal potch.

Because of the layered structured of the sandstone beds, much of the infill opal is in narrow semi horizontal veins or seams. These vary from 1mm up 10mm in thickness and are very occasionally much thicker. After being ripped up, any slabs that are found to be opal bearing are saved. These are subsequently broken up to try and retrieve any precious opal, especially that showing the black body, which has often sold for thousands of dollars per ounce and up to \$10 000- per carat when cut.

Historically, in the opal-miners quest to sell every ounce of cuttable opal, virtually all the big slabs of opal-bearing stone were broken down to a small size.

The present specimen is indeed a rare piece. The large size has been retained and much of the large surface of opal shows swirls of color, both against the jelly blue background but also the black opal body. It is indeed worthy of being the centerpiece in any display of opal. While other opals may have wonderful flashing color, they are invariably small. This large Mintabie opal, the best of its kind, has that 'wow' factor to attract the eye to any cabinet.

#### Hydrophane Opal with Intense Fire

Wello, Delanta Plateau, Tigray, Ethiopia

This is an excellent precious opal from the leading local mine found in Wello province, Delanta region, around 2700 ft above sea level and 570 km northwest of the capital city Addis Ababa. Discovered in 2008 gem crystal and hydrophane opal from Wello Ethiopia has recently come to the international market. Mined only by the local farmers who are currently banding together to form small mining cooperatives, the Ethiopian Ministry of Mining and Energy is making efforts to train them on mining safety, polishing, and market conditions.

Mineralogically speaking Wello opal is very different from Australian opal. In composition it may be most similar to Indonesian opal. Australian white opal, which some may superficially think has a similar appearance, is actually formed of silicon spheres stacked one on top of the other, creating a diffraction grating that disperses light entering the opal. The Wello material, on the other hand, has no spheres, but instead possesses a totally different structure altogether. The color display patterns range from rolling holographic orbs and dots to sheet, to flagstone to broadflash, to rolling ribbons and threads and exhibit some wave-like patterns as well.

Wello material is hydrophane opal that is porous—a Wello opal put in water may siphon up the water through capillary action, which usually causes the beautiful neon colors to disappear. Once the opal is taken out of the water and placed on something absorbent, the water will seep out, and the colors make their appearance again as the opal dries.

This oval cabochon exhibits the most desirable qualities of this new find: good translucency, a creamy to white body color and lively broad flash of extensive red, orange, yellow and green to the well-formed dome. 

### Artists' Biographies and Index

#### Hermann Grimm

The firm of Friedrich Philipp Grimm was founded in Idar-Oberstein in the 19<sup>th</sup> Century and was renamed as the firm of Hermann Grimm in 1926. The firm is now in its fifth generation and consists of a team of nearly 20 gemstone cutters specializing in custom gemstone carving and working with rare gemstones.

#### Jenador

Jennifer Benaim works under her artist's pseudonum, Jenador. Her unique story starts in the Outback town of Lightning Ridge, Australia where many a crusty miner hunts for opal.

Quenching his thirst for adventure, her father, Henry, led the way with his wife Dorothy and six children in tow during some harsh times. With her pioneering father, life as a child was just one big adventure, Jennifer warmly recalls. Yet it was Henry's mining knowledge above the ground and not below it that held the key to Jennifer's future. Dad became a gem dealer, regularly traveling to Coober Pedy and White Cliffs. She would often journey with him and come across opal craft, often made by the wives of miners. While browsing during one such trip, small puttogether pictures made from scratched pained glass with glistening opal inserts stopped them in their tracks. They realized that the concept could be developed into something special through hard work and diligence. Jennifer (then 17) embarked on a work regime in partnership with her father that extended another two decades until Henry's untimely death. She continues to create the highest quality opal art using an intricate technique of embedding precious stone into the design lines of etched glass, a concept that for one piece of artwork can take six months. She's passionate about placement and takes meticulous care every step of the way, eager to show off the gemstone's brilliant rainbow appeal. The carat weight and the amount of pieces of opal embedded accompany each piece. Jenador's work is exhibited in many galleries and private collections around the world.

#### Kenneth Mansergh

1959 a brooch was chosen as a gift to the young Princess Alexandra of Kent to mark her visit to Australia. The piece had been made by a young Sydney jeweler named Kenneth Mansergh.

Shortly after Kenneth developed his design workshop that was to receive many important awards over the coming decades, among them 2 Diamond International Awards, 7 Australian Design Awards and a commission for "The Diamond Rose" to celebrate the opening of the Sydney Opera House.

H.M. Queen Elizabeth II was to receive a spectacular piece of Kenneth's creativity when she was presented with a solid gold and diamond replica of the wishing well featuring "Islay" (Queen Victoria's favorite dog) to celebrate the opening of the Queen Victoria Building.

The Commonwealth Government commissioned special items for various heads of state visits including gifts for The Shah of Persia, The President of Burma and The First Lady of the United States: all of these were made by Kenneth Mansergh.

Kenneth freely admits to an insatiable enthusiasm for creating beautiful jewelry notable for their traditional "by hand" craftsmanship. Lot 2036

#### Nicolai Medvedev

Nicolai was born in 1950 in Ashkhabad, republic of Turkmenia. He was formally trained as an artist in the western European tradition both in art institutes in Ashkhabad and Moscow. His early art was influenced by French Impressionism and he painted in oils creating sunlit landscapes and still lifes. His eye for pattern and color, however, was schooled by daily life in his native Turkmenia, a land of carpets, mosques, and woven textiles. Always fascinated by minerals and gemstones, Medvedev would travel for hours on trains from Moscow to St. Petersburg to admire the massive malachite urns and lapis faced columns of the Hermitage Museum.

In 1980 Nicolai emigrated to the United States. There he exchanged his minerals suspended in linseed oil for the intensity and magic of the minerals themselves, virtually reinventing the tradition of *pietra dura*, or stone inlay, in the process.

Nicolai uses the colors of light - intense greens, golds, blues, pinks, and violets -created in the darkness of the earth's crust. Choice slivers of lapis lazuli, gold in quartz, rhodochrosite, azurite, malachite, sugilite, and opal are cut, polished, and placed in precise and startling juxtaposition to make his signed, one-of-a-kind pendants and boxes. Inspired by the geometric patterns of Turkmenia and the palette of the Impressionists, Medvedev's designs have recently come to assimilate the motifs and colors of the American Southwest, the source of many of his raw materials. Though he has cut thousands of stones, he is still surprised when he slices through a specimen to find the wings of a butterfly, a lotus flower, a night sky, or a gentle Tuscan landscape hidden in the rock. It is that continuing revelation that keeps the artist working in so labor-intensive a medium, inventing forms and frames for nature's own pictures.

The designs for a box almost always begin with an image he sees in a stone, and while the size and shape of the finished piece depend on that central picture, the box itself often suggests another natural form. Nicolai also plays with the solidity of the box, creating the illusion of windows on its surface. The openings can offer a view inward toward a darker, more intense image, but just as often they look into the skies of opal, azurite, or lapis lazuli; and the element of surprise isn't limited to the exterior of the box. The artist often breaks the spatial limits of the box by creating intimate vistas on the interior with "picture" jasper and other stones.

Today Nicolai Medvedev is considered a master lapidary of stone intarsia. He resides in New Jersey, and his boxes and pendants are collected worldwide and his work has been shown in major museums including the National Gem and Mineral Collection at the Smithsonian. 2018, 2019, 2020

#### Gerd Moser

Born on August 18th, 1950 in the village of Herrstein near to Idar-Oberstein, Germany. He began his education as a gemstone carver in 1965 and finished as a Master Gemstone carver in 1973. Founding his own company in 1976, together with his wife, Edith Moser and his son Sebastian Moser, they have built a successful and prosperous carving business which still exists today. They create outstanding one-of-a kind gemstone masterpieces.

#### Sylivia and Luis Alberto Quispe Aparicio

Syliva and Luis Alberto Quispe Aparicio, follow a second-generation family tradition in the fabrication of *objets d'art*. More than 45 years ago, their father Vicente Quispe, originally a hobby mineral collector, turned professional, attended the Munich gem and mineral show and fell in love with carvings from Idar-Oberstein which he saw exhibited there. A few years later he established his own studio in Lima, Peru with the vision of becoming the top South American studio in the art of gemstone carving.

Sylvia, a goldsmith and jewelry designer who studied in Idar-Oberstein, today lives in Zurich where she designs for their studio. Her brother, Luis Alberto, trained in industrial engineering and marketing, is in charge of design work and their studio in Lima. Sylvia and Luis Albert grew up surrounded by an environment of art work, carvings, sculptures, rough stones, minerals and the artists and master carvers who continuously visited and worked at their family studio. Their own designs are inspired by wildlife and merge sculpting techniques with those of jewelry fabrication. It is their unusual design work that separates them from traditional carving from the Old Continent.

Today their studio specializes mostly in carving ruby. The second hardest stone after diamond, few artists have managed to successfully work this stone since it requires a very advanced technique for both carving and polished involving two or three times as many tools and time. Their works are displayed in museums in the United States and Europe and enjoyed by private collectors around the world.

Born in 1944, Manfred Wild, an eighth-generation gem cutter, is one of the most renowned lapidary artists to emerge from Idar-Oberstein. At the age of twenty, during an apprenticeship with a gemstone merchant, he began his well-rounded educational journey in the areas of fine art, gemstone cutting, engraving and goldsmithing.

Working in a family tradition of stone cutters established in 1630, Manfred Wild is one of the world's most famous creators of "objets d'art." He is best known for his virtuoso work in rare, precious and semi-precious materials carved as perfume bottles, animals, whimsical figures, flower studies, enameled eggs with concealed "surprises", cameos, chalices and *objets de fantaisie* made of precious stones, gold and silver.

It is helpful, of course, to understand Wild's work within the greater context of 19th and 20th Century Decorative and Jewelry Arts. In addition to the influence of his own family and town, Mr. Wild follows the traditions established by René Lalique and Peter Carl Fabergé (Russian jeweler, 1846-1920) and a great number of parallels can be seen in their work. Fabergé had begun a new era in the Jewelry Arts. Prior to him. many iewelers felt the value of iewelry was intrinsic, based upon the stones (particularly diamonds) and precious metals. The artistic creativity and superior craftsmanship introduced by Fabergé made such objects transcend their "break value". Fabergé also used a number of decorative techniques attributable to French 18th Century goldsmiths, e.g. the art of quilloché, a surface treatment of metal that could make waved lines or striations in the design, either performed by machine or by hand. Atop the *quilloché* decoration was a translucent enameling that required the application of several coats and the "firing" of the object in an oven after each layer, a very labor-intensive technique. The limited palette of enamels used in the nineteenth century was expanded upon by Fabergé who, after much experimentation, arrived at over 140 shades. He also used natural stones often found in his local area or native to Russia, e.g. jasper, agate, bowenite, nephrite. Often his use of precious stones, including sapphires, rubies and emeralds was in an understated way, only for accents, and even then were used en cabochon. Diamonds, if used, were typically rose-cut. So many of the aforementioned decorative elements are seen the work of Wild even as they appear in the examples on these pages. When India Early Minshall, a wealthy collector of Fabergé purchased an egg in 1944, she stated, "Fabergé was called the Benvenuto Cellini of the North, but I do not think any jeweler can ever be compared to him"—She could not know that someday the work of Manfred Wild would rival the work of the great Russian jeweler.....

Mr. Wild's works are displayed in museums throughout the world including: The German Gemstone Museum in Idar-Oberstein, The Smithsonian Institution in Washington, D.C., The Harvard Museum in Boston, The Carnegie Museum in Pittsburgh and The Iksan Jewellery Museum in Korea, as well as extensive private collections in Japan, Europe, the Middle East, and the United States of America.
