LOVING CUP PRESENTED TO COLONEL CHARLES P. HOMER BY THE BOARD OF MANAGERS OF THE SILK ASSOCIATION OF AMERICA.

#### A Tribute to Long and Faithful Service

AHIGH compliment was paid to Colonel Charles F. Homer by the Board of managers of the Silk Association of America by the extension of that body to him of a testimonial dinner, given at the Belvidere of the Hotel Astor on the evening of March 10. Colonel Homer has capably filled the office of treasurer of the official silk body for the past ten years and during his incumbency has rendered valuable service, taking active part in the work of the association as a member of the board of managers and various important committees.



From 1851 to 1891, Edward C. Moore was Head Silversmith for Tiffany. Following the Civil War and his father's retirement as Head Silversmith, Moore was free to engage in more adventurous design. The United States' interest in the Near and Middle East in the late 1800s finely aligned with Moore's personal fascination with Islamic style. Moore became a pioneer for Tiffany; his Saracenic designs capitalizing on the blossoming fascination with the "exotic", as evident through recent World Fairs. The first recorded Islamic-style silver by Tiffany was at the 1867 Paris Exposition Universelle. This Islamic-inspired aesthetic ranged from simple engraved works, to more opulent repoussé, mixed metal, and enamel designs. Moore encouraged the other Tiffany designers to use Islamic motifs as influence, establishing Tiffany as an innovative force.

This particular Loving Cup accentuates Moore's inventive use of repoussé, curved forms, and mixed metal inlavs. It mimics the appealing decorative effect visible in the 1889 "Saracenic Loving Cup", displayed at the 1889 Paris Exposition Universelle. The cup is also similar to an Indian-style silver and enamel Elephant's Foot Loving Cup, also designed by Moore and present at Exposition. The curvilinear form, foliate decoration, and hybrid Near, Middle, and Far East designs amplified a unique perspective of foreign culture in the United States. This specific cup was awarded to Charles Homer in 1910 by the Board of Managers of the Silk Association of America.

Col. Charles Frederick Homer (1840 - 1911) was a Civil War Veteran, who joined the 37th Regiment, N. G. N. Y. in 1862 as First Lieutenant Co. H. and Lieutenant Colonel of the 171st Regiment N. G. N. Y., 1898. He began his working career in shipping and importing, which slowly shifted him to the silk industry. Homer originally worked at the House of Pegram & Meyer, and later evolved into general silk manufacturing for various offices on Prince Street. A member of the Chamber of Commerce of New York State, New England Society, and the Union League and New York Athletic Clubs, amongst several other organizations, Homer was a prominent figure in New York society. During Roosevelt's administration. Homer was appointed as a member of the Board of Visitors to attend the annual examinations at the United States Military Academy in 1906 by William H. Taft. In 1910, this Tiffany Loving Cup was presented to the Colonel at a Silk Association of American testimonial dinner. The ceremony was held at the Belvidere of the Hotel Astor in commemoration for Homer's work as their Treasurer. The photograph of the cup and the dinner were published in the Silk Journal in March 1910, Volume III, No. 5.

This cup was presented to Bonhams by Homer's descendants.

Julian B. Hubbell (1847-1929) was the first American Red Cross Chief Field Agent and a close friend of Clara Barton, founder of the American Red Cross. Hubbell directed the day-to-day relief operations for the organization, while also participating in the field work when necessary. Beginning at the organization's founding in 1881 to his resignation in 1904, Hubbell worked nationally and internationally to alleviate suffering after calamitous events such as the 1888 Mount Vernon cyclone, the 1896 Armenian and Turkish famine, and the 1899 Cuban post war recovery. In 1892, Hubbell traveled to Russia during that country's devastating famine, organizing and distributing aid to the people.

This tea set was presented to Julian B. Hubbell of the American Red Cross as a gift from Russian Prince Cantacuzène. The gift was presented by the Prince at the Imperial Legation in Washington on 27 May 1893, following the ceremonies on board the Man of War on the day of the Coronation of Their Majesties. The set is accompanied with a 1893 letter to Hubbell from Prince Catacuzène, thanking him for his philanthropic aid to the suffering Russian population. It also includes a 1892 letter to Hubbell from his brother, Charles Hubbell, desiring to give more aid to the Russians.

Kirill (Karl) Fyodorovich Albrecht was appointed as the Russian Court's supplier in the late 19th century.

Marcia Ann Gavit was born in 1906 to a very well-to-do family in Albany, NY. She came from a long line of artists and entrepreneurs. Her mother, Flora Myers Brady Gavit, died tragically in a train crash in 1912. Then, when her maternal grandfather, A.N. Brady, died the following year, she became a beneficiary of his substantial estate. Newspapers across the country touted her as the richest girl in the country, while noting how insulated she was from knowing her status. When her father, E. Palmer Gavit, moved to Santa Barbara with his

second wife, they continued to live in comfort and privacy at Cuesta Linda, which would later become Lotusland in Montecito. Many of the older pieces offered in the collection are inherited pieces from this part of the family.

Rumor has it that her stepmother, Marie Turner Gavit, and her future mother-in-law, May McElroy Jackson, conspired to engineer a marriage between their children... but letters between the betrothed show the match was sincere. Ann, as she preferred to be called, married Charles Hervey Jackson, Jr. (aka Pete), in 1926. They built their dream home, Rancho San Carlos, over the next few years with the help of renowned architects and designers, as well as skilled immigrant craftsmen. The Depression was in full swing, and it was known around town that anyone could work for a month's wages if they took a month off before re-applying for their next stint.

One of Ann's closest friends was Chicago interior designer Cornelia Conger. As the house was being designed and built, Cornelia made many trips to Europe to find just the right furnishings and accessories to complete the new home. While construction was underway, Ann and Pete pursued their passions. They were avid polo players and played competitively across the country. Ann was instrumental in bringing women's polo to California, and when her polo days were behind her, she embraced horse racing. Over the course of fifty years, Ann foaled, trained and raced more than 500 horses. She was an internationally acclaimed judge at dog shows, and had a vibrant business raising champion Kerry Blue Terriers and Springer Spaniels. The trophy room at Rancho San Carlos was a testament to their

Ann and Pete unceasingly followed their passions and shared their horsemanship with their children, raising them half the year on their YP Ranch in Nevada. Cattle were moved back and forth from the YP to their Alisal ranch each year, even before Pete turned it into a guest ranch. They were champions of the Santa Barbara community through their philanthropy, but always eschewed the spotlight.

To this day Rancho San Carlos is almost unchanged from its heyday of the 1930's and 40's and represents a shining example of the gilded age of Santa Barbara.

Following England's Arts and Crafts movement, Gorham departed from the commercialized, machine-made objects, introducing a new style: Martelé. The limited hand-wrought line was active from 1896 to the 1930s, under the direction of Gorham's chief executive Edward Holbrook and chief designer William Codman.

The pieces were hand crafted in the Art Nouveau style with a hammered finish; the French word martelé meaning 'hammered'. This was possible by using a softer and more pure metal than the sterling standard. Because they were hand crafted, no two piece can be the same.

First shown at a New York exhibition in 1897 and internationally at the 1900 Paris Exposition, the pieces achieved great praise.

This set of chairs closely relates to 'The Infantado Suite' designed by Giles Grendey in the second quarter of the 18th century. Their rich red color and eastern decoration represent the style and sophistication of Grendey and his workshop.

Giles Gredney is known to have created a suite of approximately seventy-seven pieces for the Lazcano Castle in Spain during the 18th century. 'The Infantado Suite' contained chairs, bureaus, mirrors, and daybeds in red lacquer with eastern inspired decoration. It is one of the most celebrated suites of English furniture because it demonstrates the demand for all things of Eastern influence that was popular in the 18th century. The chairs are japan-painted in trompe l'oeil red and gold to resemble the fashionable lacquer imports of the East India trading companies. The suite of Lazcano furniture is represented in major museums, such as the Victoria & Albert Museum, the Metropolitan Museum of Art, New York, Temple Newsam House, Leeds, and the National Gallery of Victoria in Australia.



This sculpture, likely by prominent Flemish sculpture Peter Scheemakers, originally stood on the parapet of Barrington Hall at Broad Oak, Hatfield, Essex, together with a figure of Minerva. The classically-inspired statues were added to the residence when John Shales Barrington inherited the estate, seeking to enhance the property and family's eminence. Prudence stood as a moral emblem. The mirror, a reminder that self-reflection is key to acknowledging our faults. The snake or remora, emphasizing the need for restraint.

Originally thought to be Hygiaea, scholars have now deemed the figure to be Prudence, holding a serpent and mirror, rather than a cup. This was clarified with the discovery of Scheemakers' sketchbook from his stay in Rome in 1728-30, which contained a drawing of Lironi's statue of Prudence in St. Peters. Scheemakers was the only prominent London sculpture during this period to study ancient sculpture in Rome. Although Scheemakers version of Prudence is much more classical and passive, the sculptor's inspiration is quite distinct.

The smaller terracotta prototype of this sculpture currently resides at the Huntington Art Gallery in San Marino.










The S.S. City of Berlin was a British passenger liner built by Caird & Company in Scotland. She was the Inman Line's premier vessel for thirteen years, and won the Blue Riband for the Inman Line in 1875 as the fastest liner on the Atlantic. She was also the largest passenger ship for six years. The S.S. City of Berlin served the Inman Line until 1893 when Inman was merged into the American Line, and was operated by her new owners on both the American Line and Red Star Line until 1898. In 1895, she and the City of Chester were replaced in the American Line's weekly mail fleet by the new express liners, the St. Louis and the St. Paul. Renamed the S.S. Berlin, she was placed on the Antwerp - New York route for the Red Star Line with occasional sailings for the American Line. In 1898 the S.S. Berlin was sold to the U.S. Government for the Spanish-American War, and was renamed Meade. She trooped to the Philippines until she was damaged by a fire in San Francisco on January 31, 1906. Repaired, she continued service through World War I and was finally scrapped in 1921.



Jan Frans Verhas, a Belgian painter, received his initial training from his father, Emmanuel Verhas, an artist, teacher, and director at the local Academy and younger brother of Franz Verhas, a successful artist in his own right. Verhas studied initially at the Academy of Fine Arts in his hometown Dendermonde and from 1853 onwards at the Royal Academy of Fine Arts of Antwerp. Verhas is most known for his portraits and genre scenes of women and children set in luxurious bourgeois homes. He was an important representative of the emerging Realist movement in Belgium of the day. He was also influenced by his fellow student and subsequent lifelong friend, Lawrence Alma-Tadema.

In this Realist approach to rendering scenes of everyday contemporary life, the artist was known for incorporating a humoristic touch. His favorite subjects were children engaged in some innocent activity or mischief, which is evident and cleverly portrayed in the present work *Minor catastrophe*. Here the lovely young girl's penitent expression is one of undoubted guilt as she has overturned the entryway's blue and white porcelain gueridon with the calling cards from the receptacle now strewn across the carpet, a result of her badminton play. She remains frozen with the racquet in hand as the shuttlecock lies at her feet. The broken porcelain fragments on the carpeted floor serve as further evidence of the catastrophe. The child's natural expression gives the scene the feeling of a casual recording of the mishap. The artist's warm color palette, decorative background, opulent European furniture and drapery, exotic carpet, and delicate lace embellishments on the clothes of the diminutive culprit accentuate the bourgeois atmosphere. The whole composition is executed in a naturalistic style with attention to the rendering of the different materials and textures for which the artist was well recognized and celebrated.

Raimundo de Madrazo came from a distinguished artistic dynasty, which included his grandfather José de Madrazo (1781-1859), a neoclassical painter, and his father Federico de Madrazo (1814-1894), who trained in Paris with Franz Xaver Winterhalter (1805-1873) and was regarded as the best portrait painter in Spain.

Born in Rome in 1841, Raimundo de Madrazo lived for many years in Paris, where he was influenced by the Belgian artist Alfred Stevens and his brother-in-law, Mariano Fortuny. From that time on, his

style changed from historical and academic paintings to the more intimate genre paintings of the Belle Epoque. In 1882, with Giuseppe de Nittis, Alfred Stevens and the gallery owner Georges Petit, he co-founded the *Exposition Internationale de Peinture*, designed to promote foreign artists in Paris.

Madrazo's most characteristic works were female portraits in elegant interiors. This is well illustrated in the present work *La pintora en su estudio*, where the figures are placed in an artist's studio, which serves as backdrop that showcases Madrazo's skills in depicting sumptuous brocades, silks and period dresses in a refined and elegant setting. The motif of the female artist is a recurrent one for Madrazo. The young sitter portrayed as an artist is typically a prominent lady of society who passes her time painting in an intimate studio surrounded by her model, art supplies and decorations. The influence of Madrazo's close friend and brother-in-law, Mariano Fortuny, is clearly evident in this work in the abundance of detail and mastery of color and texture.

Madrazo enjoyed huge success as an artist all over the world, including the United States, where the Vanderbilts were perhaps his most faithful patrons.



Bachelin spent 24 years in Paris and was present during the long winter of 1870 when Paris was under siege by the Prussian army during the Franco-Prussian war. The Prussian army was vastly superior in organization and tactical strategy to the French army. It needed only one year to conquer France, capture large numbers of troupes, including Emperor Napoleon III, and lay waste to French towns on its march towards Paris. Strasbourg was one of the cities besieged and destroyed by the Prussians in 1870. In wake of its surrender, many inhabitants and soldiers fled to neighboring Switzerland.

The present composition depicts an episode in the aftermath of this brutal conflict that displaced large numbers of French citizens. A group of women and children carrying their belongings have arrived at the Swiss border, where they collapse exhausted in front of the Swiss border guards. A young boy points toward the burning village visible in the distance, while the guards lean in compassionately. Bachelin's sympathy for his adopted second country, symbolized by the refugees, as well as for the Swiss army he so often painted during his career, is quite evident in this composition. Both groups are depicted in the same dignified manner, with the standing, central figure facing the men on equal footing, speaking on behalf of her family. The Swiss guards are politely engaging the group, symbolizing the safe haven offered by Switzerland to its French neighbors.

Bachelin was born in the Swiss town Neuchâtel in 1830 but lived in Paris between 1850 and 1874, when he married and returned to his hometown, where he continued to exhibit and engage in the local literary scene. His studies with Charles Gleyre and Thomas Couture influenced his choice of history painting. He was a prolific writer of art historical articles with a marked emphasis on Swiss art and identity. As a painter, he is mostly known for his military scenes influenced by the numerous wars of the 19th century. The Franco-Prussian war featured prominently in his albums Aux frontières: neutralité, humanité, 1870-1871: notes et croquis; and L'armée de l'Est en Suisse: notes et croquis.





      (II) No more than two (2) depositions per party, provided however, the deposition(s) are to be completed within one (1) day; (III) Compliance with the above shall be enforced by the arbitrator in accordance with New York law;
    - D. Each party shall have no longer than eight (8) hours to present its position. The entire hearing before the arbitrator shall not take longer than three (3) consecutive days;
    - E. The award shall be made in writing no more than 30 days following the end of the proceeding. Judgment upon the award rendered by the arbitrator may be entered by any court having jurisdiction thereof.
